The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, March 7, 2023 in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other, Supervisors present: Tom Brouillette and via phone Vince Phillips. Supervisor Absent: None. Also, present was Auditor Peggy A. Rolph.

Motion was made by Supervisor Fox, seconded by Supervisor Brouillette to approve the agenda. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

Present for the Mapleton Law Enforcement discussion were Brent Streck, Mapleton Mayor; Abby Koenigs, Mapleton Mayor Pro Tem; Sheriff Jeff Pratt; Sgt. Jeremy Bellis, Sgt. Kevin Ewing; and Abby Riesberg, Treasurer. Brent and Abby expressed their concerns on the direction of law enforcement in Mapleton since the County has hired Mapleton's Chief of Police. Discussion followed with no action taken.

Secondary Roads Engineer Dustin Wallis was present for Secondary Roads business. Motion was made by Supervisor Fox, seconded by Supervisor Phillips to acknowledge receipt of resignation letter from Kelly Bothwell effective May 1, 2023. Cindy updated the Board that the Committee have been meeting monthly and will have an update for the Board within a few months. No action was taken.

Onawa Drainage District: Supervisor Phillips received a picture of damage to an intake at 10th and Maple Streets from the City of Onawa. Contact was made with John Casady, Public Works Administrator for the City of Onawa, who informed the drainage office that the repairs were the responsibility of the city since it was an intake inlet issue and they would be taking care of the repair costs.

A petition was filed by William L Noble on the Fletcher Drainage District on 3/2/2023 requesting drainage improvement due to restricted drainage on his property located in Section 9-82-45, Sherman Township. The Board of Supervisors accepted the petition, as filed, and Chairman Fox will make contact with the involved landowners and tenants to discuss options. No action was taken on the petition at this time.

Kelly Seward, Recorder was present to update the Board on the scanning contract that she has received from US Imaging, Inc. US Imaging, Inc. will update the quote to include more books to be scanned. No action was taken.

MONONA COUNTY ORDINANCE NO. 68

TITLE: An amendment to the Monona County Zoning and the Official Zoning Maps.

BE IT ENACTED by the Board of Supervisors of Monona County, Iowa:

SECTION 1. Purpose: This ordinance amends the current Monona County Zoning and Official Zoning Maps for NEW Cooperative, Inc.

SECTION 2. Amendment: The Monona County Zoning and Official Zoning Maps shall be amended to reclassify the following described real property from A-1 (Agricultural District) to A-2 (Agribusiness District)

A parcel of land located in the NW ¼ SE ¼ of Section 7, Township 82 North, Range 45 West of the 5th P.M., Monona County, Iowa described as follows:

Commencing at the NE Corner of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 7-82-45, thence S $01^{\circ}02'$ 43" W 820.49 feet along said line, thence N 88° 57' 17" W 1,134.96 feet to a point on the centerline of a road, thence Northeasterly 784.45 feet along said centerline along a 4,500 foot radius curve concave Northwesterly with a long chord bearing N57° 23' 01" E 783.46 feet, thence N 52° 23' 23" E 618.33 feet along said centerline to the point of beginning. Said parcel contains 10.00 acres more or less including the presently established county right-of-way.

SECTION 3. Ordinance Repealed. The previously adopted Monona County Zoning and Official Zoning Maps are repealed as said Zoning Maps pertain to the above described real estate.

SECTION 4. When effective: This amendment to the Monona County Zoning and Official Zoning Maps should be effective after the final passage, approval and publication as provided by law.
