MONONA COUNTY BOARD OF SUPERVISORS MEETING MARCH 28, 2023

The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, March 28, 2023 in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other, Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also, present was Auditor Peggy A. Rolph.

Motion was made by Supervisor Phillips, seconded by Supervisor Fox to approve the agenda with the addition of COVID 19 Burgess Public Health update. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

Present for the Covid-19 Burgess Public Health update was Adam Hadden, Burgess Public Health via phone. Adam informed the Supervisor that there were 22 cases for the month of March and 54 total deaths. Adam said going forward the vaccine will be commercialize and will no longer be available through Burgess Public Health. Discussion followed with no action taken.

Randy Ping, Temporary Part-Time Custodian was present about purchasing water sensors to be installed on the sub pumps in the basements and what would be required to get air conditioning in the annex. Discussion followed on the air conditioning in the annex, no action taken

Charlie Persinger, Monona County Economic Development was present for public comments to discuss the grant proposal with NEW Cooperative, no action was taken.

Present along with the Supervisors and Auditor for the Elected Official / Director Meeting were Don Thompson, Veteran Affairs; Dustin Wallis, Engineer; Jim Wigton; IT Director; Kelly Seward, Recorder; Ian McConeghey, County Attorney; and Patrick Prorok, EMA Director. Absent Abby Riesberg, Treasurer; Doug Kuhlmann, Conservation Director; Jeff Pratt, Sheriff; Sandy Bubke, Zoning/Environmental Health Administrator; and Tim Peters, Assessor. Activities were discussed and information was shared.

Secondary Roads Engineer Dustin Wallis; Zach Schrader, Assistant to Engineer; and Shawn Hamann were present for Secondary Roads business. Motion was made by Supervisor Fox, seconded by Supervisor Brouillette to approve internal posting for Operator III (Soldier Shed). Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion Carried.

Motion was made by Supervisor Brouillette, seconded by Supervisor Fox to approve external posting for three Roadside Operator position (Seasonal Help). Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion Carried.

Discussion items were rock hauling, tubes extensions, job posting for Shop Foreman position in the Sioux City Journal and Omaha World Herald, Safety Training update, mechanic's shed, and motor grader repairs. No action was taken.

A petition was filed by Hulstein Land LLC on McNeill Lateral No. 6 on March 22, 2023 requesting authorization to install drain tile into McNeill Lat 6 and one tile into the McNeill Main ditch on the east end of their field and also clean a few spots that are filling up on Lateral 6 where their surface drains drain into the ditch.

After talking with Hulstein he indicated they had a contractor coming in to do some work and would remove the silt, as indicated in the petition, where their surface drains drain into the ditch. A drive by inspection was done by Chairman Fox, Trustee Brouillette and Bryan Phillips. They noticed other areas where silt had deposited in other areas of the lateral. Contact was made with Matt Smolders, as requested by Hulstein, to see if the contractor would be willing to spot clean the additional areas also as long as he was there and send us an estimate of the cost.

It was moved by Fox, seconded by Brouillette to approve the petition and have the contractor complete the additional areas once we have approved the estimate. Vote on motion: Ayes: Fox, Brouillette and Phillips. Nays: None. Motion carried.

McNeill Main Phase 1: Engineer Pech summarized the contractor qualifications and references of Hendrickson Transportation LLC of Hamburg, Iowa, which was detailed in a letter we received from ISG. After the summary it was agreed that the contractor appears to be more than qualified to perform the work for the McNeill Main Ditch Phase 1 project.

It was moved by Rife, seconded by Fox to award the contract for the McNeill Main Ditch Phase 1 repairs to Hendrickson Transportation LLC of Hamburg, Iowa, as low bidder for \$937,135.11. Vote on motion: Ayes: Fox, Phillips, Brouillette, Straight and Rife. Nays: None. Motion carried.

The next step will be to review and sign the prepared contract next Tuesday, April 4, 2023, @ 10:00 a.m., as a joint board through a conference call.
