The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, July 5, 2023 in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other, Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also, present were Deputy Auditor, Sheri Streeter and Wray Wright.

Motion was made by Supervisor Phillips, seconded by Supervisor Fox to approve the agenda. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

Joel Bubke was present to discuss the entrance to his field. The concrete box culvert needs some repair work done. Asked about a possible widening of the entrance. The board told him to contact Wally at the Mapleton shed to look at it, no action taken.
