MONONA COUNTY BOARD OF SUPERVISORS MEETING DECEMBER 5, 2023

The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, December 5, 2023 in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other, Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also, present was Auditor Peggy A. Rolph.

Motion was made by Supervisor Phillips, seconded by Supervisor Fox to approve the agenda with adding Resolution 2023-30 Resolution to Sell at Public Auction by Sealed Bid with a Minimum Bid of \$100 to the Highest Bidder for Cash Certain Properties Acquired by Monona County, Iowa. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

Present for the approve/disapprove window/door replacement bid were Todd Wright, Global Glass & Glazing, LLC; Randy Ping, Maintenance; and Kevin Ewing, Sheriff. Motion was made by Supervisor Fox, seconded by Supervisor Brouillette to approve the base bid of \$377,848 from Global Glass & Glazing, LLC. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

Sheri Streeter, Election Deputy and Kevin Ewing, Sheriff were present to draw lots for the Moorhead City Council. Chairman Fox drew the name of Tiffany Eastwood for the Moorhead City Council Seat. No action needed.

Present for the acknowledge receipt of Monona County Attorney's resignation letter were Ian McConeghey, County Attorney, Kevin Ewing, Sheriff, Kelly Parsley, Deputy Auditor; Jack Reed and Chelsea Stoll, INCS.

Motion was made by Supervisor Brouillette, seconded by Supervisor Fox to acknowledge receipt of Monona County Attorney Ian McConeghey's resignation letter effective January 2, 2024. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

At 9:11 a.m., Supervisor Fox made the motion, seconded by Supervisor Phillips to go in to closed session per Iowa Code 20.17 (3). Jack Reed and Chelsea Stoll Iowa Negotiations Consulting Services; Kevin Ewing, Sheriff; and Kelly Parsley, Deputy Auditor were present. Vote on motion: All Ayes. Motion carried.

It was moved by Supervisor Fox, seconded by Supervisor Brouillette to come out of closed session at 10:15 a.m. Vote on motion: All Ayes. Motion carried. No further action taken.

Present for the McNeill Drainage District discussion was ISG Engineer Caleb Rasmussen and Bryan Phillips, Drainage Clerk. Engineer Rasmussen discussed some of the additional work Hendrickson conducted at Holly Avenue with extra road excavation for Secondary Roads and was asking for additional compensation in the amount of \$8,300. The Board asked to split the cost between the District and Hendrickson. Caleb will speak with Hendrickson about this matter. Final pay estimate will be presented at the next meeting. There are a couple tubes along the ditch that have sediment and need to be jetted. It was moved by Fox, seconded by Brouillette to hire Brian Kepner with RQP LLC to jet two tubes draining in the ditch in the amount of \$900 per tube for a total of \$1,800. Vote on motion: Ayes: Fox, Phillips and Brouillette. Nays: None. Motion carried.

Present for Onawa Drainage District 11th Street Drainage improvement discussion was Veenstra & Kimm Engineering Patrick Mouw and John Casady, City of Onawa Pubic Works Administrator. Engineer Mouw presented plans, specifications and contract documents to the Board of Supervisors for the Onawa Drainage District 11th street drainage improvements. A letting date is set for January 12th, 2024. Sealed bids shall be delivered to the drainage office by January 12th at 4:30pm. Bid opening will take place on January 16 at 10am in the Basement Conference Room of the Courthouse in Onawa, Monona County, Iowa. It was motioned by Phillips, seconded by Fox to approve the plans, specifications and contract documents for the 11th street drainage improvements. Vote on motion: Ayes: Fox, Phillips and Brouillette. Nays: None. Motion carried.

Secondary Roads Office Manager Deleta Huffman; Shawn Bellis, Secondary Roads Superintendent; Ian McConeghey, County Attorney; and via zoom Scott Kruse and Derrick Thomas WHKS & Company were present for Secondary Roads business. Discussion items during the zoom meeting were FEMA project, E16 project closeout, the Secondary Roads budget, new equipment, a work order program using free software developed by the Iowa County Engineer's Association, a gravel road maintenance plan, pavement condition review, safety items, and the Onawa Country Club Road. No action taken.

Motion was made by Supervisor Phillips, seconded by Supervisor Fox to authorize the Chairman's signature on required Local Public Agency Project Documentation & Pre-Audit Checklist. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

It was moved by Supervisor Fox, seconded by Supervisor Phillips to open the Public Hearing regarding the sale of three pieces of property owned by the County at 11:30 a.m. Vote on motion: All Ayes. Motion carried. With no one present to object to the sale, it was moved by Supervisor Fox, seconded by Supervisor Brouillette to close the hearing at 11:45 a.m. Vote on motion: All Ayes. Motion carried.
