MONONA COUNTY BOARD OF SUPERVISORS MEETING MAY 14, 2024

The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, May 14, 2024 in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also present were Auditor Peggy A. Rolph and Wray Wright.

Motion was made by Supervisor Fox, seconded by Supervisor Brouillette to approve the agenda with adding Approval of Amending Subdivision Ordinance Chapter 200 Section 200.04 Definitions.40(B)(2) and changing Secondary Roads Agenda by removing Resolution SR24-18 Set Public Hearing for Road Vacation and adding set Public Hearing date and time for road vacation. Wray Wright and Sheriff Ewing were present for open vehicle bids. The bid from Knoepfler Chevrolet was for a 2024 Chevrolet Silverado PPV with upfit \$73,215, discount of \$500, trade in of 2018 Ford F150 \$10,500, doc fee \$179, for a total of \$62,394. Without upfit \$51,363, discount of \$500, trade in of 2018 Ford F150 \$10,500, doc fee \$179, for a total of \$40,542. The bid from Karl Auto Group was for a 2024 Chevrolet Tahoe (CK 10706) 4WD 4 door Commercial \$53,450, destination charge \$1,995, discount for options \$225, Karl's government discount \$1,950, remote start \$475, trade in of 2018 Ford F150 \$10,000, customer discount \$3,839.80, for a total of \$39,905.20. The bid from Mac's Chevrolet was for a 2024 Silverado PPV with upfit \$72,715, trade in of 2018 Ford F150 \$14,000, for a total of \$58,715. Without upfit \$53,485, trade in of Ford F150 \$14,000 for a total of \$39,485. A bid tab will be put together for approval at the next Supervisor's meeting. No action taken.

Monona County Desires to place Granular Surfacing Material on several Farm to Market routes in Western Monona County.

Each bid item represents a segment of road that shall receive 250 tons per mile of 1.5" Road Stone. The supplied product shall be limestone meeting the gradation listed in the contract documents. All trucks shall be belly dumps or end dumps with gates and chains that can be set for uniform spreading along the designated routes. The unit price shall include all labor, materials and equipment to complete the necessary hauling to complete the project.
