MONONA COUNTY BOARD OF SUPERVISORS MEETING JUNE 11, 2024

The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, June 11, 2024 in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other, Supervisors present: Vince Phillips and Tom Brouillette arriving at 8:35a.m. Supervisor Absent: None. Also, present were Auditor Peggy A. Rolph and Wray Wright.

Motion was made by Supervisor Fox, seconded by Supervisor Phillips to approve the agenda. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

Kevin Ewing, Sheriff, was present to discuss the current vehicle situation. Discussion followed. No action taken.

Wray Wright inquired about hiring a County Engineer, overload weights on the roads, and farm to market roads. Discussion followed with no action taken.
