The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, June 18, 2024 in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other, Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also, present was Deputy Auditor Sheri Streeter and Wray Wright. Supervisor Phillips departed from the meeting at 10:00 a.m.

Gary Taylor is going to make one more attempt to talk with the previous contact he had with Union Pacific Railroad (Jeremy) to see if he can get any answers regarding how the Railroad would like to proceed with the McNeill Main Cleanout Phase 2. There have been over 50 attempts for communication from 12 different people with no follow up from UPRR at this time, including the letter they were served as required by Iowa Code 468.109. Rasmussen will work on getting an informational meeting set for the landowners the beginning of July, so they can be informed of the 4 options presented by ISG to proceed with Phase 2. Rassmussen will reach out to Brian Rife with the Harrison Board of Supervisors to let him know where the project is at as well.
