NOW, THEREFORE, BE IT RESOLVED that we, the undersigned members of the Board of Supervisors and *ex officio* Board of Canvassers of Monona County, Iowa, do hereby certify the following TURNOUT REPORT and RESULTS in the GENERAL ELECTION, held November 5, 2024, and that no obvious clerical errors were identified during the canvass.

Three thousand one hundred twenty-eight (3128) people voted at the polls on Election Day. One thousand five hundred forty-one (1541) absentee ballots were accepted for counting. Zero (0) provisional ballots were accepted for counting. A total of four thousand six hundred sixty-nine (4669) people voted.
