**WHEREAS:** there are needed changes in the thresholds set in the previous Resolution No. 2014-35 and ranges are needed for capital assets of the county to be depreciated using the straight line method.

**NOW, THEREFORE, BE IT RESOLVED,** for financial purposes, the fixed assets threshold will be \$10,000, building and land will be \$25,000 and infrastructure will be \$50,000. The ranges for estimated useful lives for asset reporting will be:
