MONONA COUNTY BOARD OF SUPERVISORS MEETING JULY 22, 2025

The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, July 22, 2025, in the boardroom of the courthouse in Onawa, Monona County, Iowa, with Chairman Fox presiding. Other Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also present was Auditor Peggy A. Rolph.

Motion was made by Supervisor Fox, seconded by Supervisor Phillips to approve the agenda. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

Rasmussen stated County Engineer Bechtold was tentatively on board with using flexamat in McNeill Lateral 8. He needed a little more information from Rasmussen.

A signed memorandum by Engineer Rasmussen for Maple River Lat 1- Landowner Levee Repairs, Bob Steiner, was placed on file.

Rasmussen is still waiting to hear back from the utility company in coordination with the Crane Intercounty Ditch. We are looking at construction possibly this Spring.

McNeill Phase I was discussed, Chairman Fox asked Rasmussen to give Thomas Pekarek a call about a concern he had on the slope.

The City of Onawa did the cleanup discussed last week by the utility poles they installed.
