MONONA COUNTY BOARD OF SUPERVISORS MEETING NOVEMBER 12, 2025

The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Wednesday, November 12, 2025, in the boardroom of the courthouse in Onawa, Monona County, Iowa, with Chairman Fox presiding. Other Supervisors present: Tom Brouillette. Supervisors Absent: Vincent Phillips. Also present was Auditor Peggy A. Rolph.

Motion was made by Supervisor Fox, seconded by Supervisor Brouillette to approve the agenda. Vote on motion: Ayes: Fox and Brouillette. Nays: None. Motion carried.

Haley Bryan, County Attorney, was present to discuss ISAC request for financial support.

Placing the spoils on adjacent farmland at his own expense. The adjacent landowners and farmland tenants have given permission to deposit the spoils on their property.
