SEPTEMBER 8, 2026**

The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, September 8, 2026, in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also present was Auditor Peggy A. Rolph.

Motion was made by Supervisor Fox, seconded by Supervisor Phillips, to approve the agenda. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

Present for public comments were Sandy Bubke, Zoning Administrator, Wray Wright, Robert Bianchini, and Kevin Alons, State Senator District 7. Sandy discussed with the Board the ongoing issues with the DNR and IDALS that are bypassing the Monona County Zoning Ordinance.
