AGREEMENTS

The applicant agrees that if granted a permit to do said work the following stipulations shall govern:

- The applicant shall carry on the construction, repair and maintenance with serious regard to the safety of the traveling public and adjacent property owners and shall save Monona County and the Monona County Secondary Road Department harmless of any damage or losses that may be sustained by the traveling public on account of any and all associated activities within the County Right-of-way or covered by this permit.
- Right-of-way or covered by this permit.
 2. The applicant shall indemnify and save harmless Monona County and the Monona County Secondary Road Department and their employees, from any and all actions, suits at law or in equity, for losses, damages, claims or demands, and from any and all liability and expense of whatsoever nature, arising out of or in connection with the applicant's use or occupancy of the public road and rights-of-ways.
- 3. The applicant shall hold Monona County and the Monona County Secondary Road Department harmless of any damage that may result to said road because of the construction or maintenance of the facility, and shall reimburse Monona County or the Monona County Secondary Road Department for any expenditures Monona County or the Monona County Secondary Road Department may have to make on said road rights of way on account of said applicant's construction or maintenance activity or lack thereof.
- 4. Traffic protection shall be in accordance with Part IV of the current Manual on Uniform Traffic Control Devices for Streets and Highways. The Applicant shall be responsible for providing and maintaining the appropriate traffic control as required by the Manual.
- 5. Before beginning any work within the road rights-of-way, it is the responsibility of the applicant to contact utility companies may be affected or encountered. Contact should be made at 1-800-292-8989, a minimum of 48 hours in advance of starting activities. If the work requested in this application should cause a need to relocate or modify an existing utility, any cost associated shall be as negotiated between the applicant and the utility owner.
- 6. A copy of the approved application shall be on the job site at all times, during construction, for examination by County officials.
- 7. The applicant shall seed and mulch all disturbed areas within the road right-of-way and shall be responsible for vegetation cover until it becomes well established. The applicant shall be responsible for establishing the vegetation for the period of one year after the permit's expiration.
- 8. If the proposed work results in a pool of water on the applicant's property, this pool of water will be exclusively owned, controlled and maintained by the applicant. That part of the modification located on the road right of way will be maintained by the Monona County Secondary Road Department for road purposes only.
- 9. The applicant shall maintain any drainage structure built within the right-of-way that is for the benefit of the applicant and not necessary for road use.
